This Memorandum of Understanding is made and executed on 5th January 2022 at Visakhapatnam.

BY AND BETWEEN

Dr.Lankapalli Bullaya College Visakhapatnam, represented by Dr. G.S.K. Chakravarty, Principal who is duly authorized to sign and execute the MoU.

Being the First Part

AND

Suraj Krishna Greenaries, an authorized agency of Indian Trading Company (ITC) having its principal office situated at D.NO-37/1052-AI, Nehru Nagar, Kadapa-516002. Ph:8309657266 and Represented by Mr. K.Rama Chandraiah, Managing Partner referred as
“Suraj Krishna Greenaries”

Being the Second Part

Whereas Dr. Lankapalli Bullaya College Visakhapatnam has agreed to collect and give away the dry recyclable waste including any kind of paper waste and old records generated in its college and form Swachh WOW Andhra Pradesh Chapter.

1. NOW THIS MOU WITNESSES AS THERE UNDER:

This is an agreement for a synergic alliance between Dr. Lankapalli Bullaya College and Suraj Krishna Greenaries for the social cause of recycling of Dry Waste and Environment Protection through recycling.

2. Time period: This MOU shall be for a period of two years commencing from the date of signing of this MOU.

3. **Roles and Responsibilities of Dr. Lankapalli Bullaya College Visakhapatnam:**

- a. To ensure source segregation of dry and wet waste at College premises.
- b. Dr. Lankapalli Bullaya College will give away any kind of paper waste, dry recyclable waste and old records to Suraj Krishna Greenaries at price agreed mutually. Suraj Krishna will pay at below rates:

White paper & News Paper:	:	Rs.12/kg
Atta:	:	Rs.3/Kg
Carton Boxes:	:	Rs.7/kg
Hard Plastic (Pipes, Chairs, White drink bottles)	:	Rs.12/kg
Color Drinking bottles	:	Rs.12/kg
Low grade plastic	:	Rs.2/kg
E-Waste	:	Rs.12/Kg
Low grade Iron	:	Rs.20/Kg
High grade Iron	:	Rs.25/Kg

- c. The college shall support WOW activities to be conducted by Suraj Krishna Greenaries without prejudice to the regular academic activities of the students
- d. The College may provide students for Internship in WOW Program.
- e. The college shall motivate students to bring dry recyclables like paper, plastic, metal etc. from their home and donate to WOW initiative.
- f. The college will put-up color-coded bins for waste segregation at different points in College premises.

4. **Roles and Responsibilities of Suraj Krishna Greenaries:**

- a. ITC-AGS (Academy of Gadhian Studies) will train the students and housekeeping staff on source segregation and through them inculcate the habit of source segregation among the other students.
- b. Suraj Krishna Greenaries will collect dry recyclable waste and old records from Dr. Lankapalli Bullaya College and bring to the Dry Resource Collection Centre (DRCC) without any spillage.
- c. Suraj Krishna Greenaries will organize sorting of the dry waste into different categories, baling, and appropriate disposal of dry waste.
- d. Suraj Krishna Greenaries shall coordinate with ITC and undertake necessary measures for dispatch of the sorted recyclables for recycling at its own cost.
- e. Suraj Krishna Greenaries will make payment to Dr. Lankapalli Bullaya College directly into their accounts for the dry recyclable waste collected against the accurate weighment and the type or category of the dry waste. The payment shall be made not later than 15 days from the date of purchase of dry waste from the waste collector. Franchisee on the request of Dr. Lankapalli Bullaya College may give New Notebooks and Stationery against the value of dry recyclable waste lifted.

5. **Performance of Obligations**

- a. The details laid out in this MOU, notwithstanding the essence and spirit of this MOU is an understanding between Dr. Lankapalli Bullaya College and Suraj Krishna Greenaries.
- b. Any notice or other communication under or in connection with this agreement shall be in writing in the English language and shall be delivered personally or sent by way of e-mail to the party due to receive the notice or communication at its address set out in this contract or such other address as either party may specify by notice in writing to other.

Force Majeure: Neither party shall be liable for damages for any delay or failure to perform its obligations here under, if such delay or failure is due to reasons beyond the control of the concerned party including without limitation, strikes, riots, wars, fires, epidemics, quarantine restrictions, unusually severe weather, earth quakes, explosions, acts of God or state or any public enemy or acts mandated by applicable laws, regulation or order, whether valid or invalid, of any Governmental body.

This Agreement and the Schedules together constitute a complete and exclusive understanding of the terms of the Agreement between the Parties on the subject hereof and no amendment or modification hereto shall be valid and effective unless agreed to by all the Parties hereto and evidenced in writing.

NOTICE /Termination


